RESOLUTION TO PURCHASE MUNICIPAL SOFTWARE SYSTEM FOR THE TOWN OF LISBON

WHEREAS, the Town of Lisbon seeks to upgrade its financial services accounting, purchasing, payroll, Town Clerk, and Codes Office software to streamline the municipal financial systems and reports, and to better integrate current statutory and regulatory requirements into the Town's financial practices to improve efficiency and assure compliance; and
