- A. Planning Board and Code Enforcement Officer Marc McDonell Meeting Minutes for Planning Board May 11, 2015 See *attachment # 1*
 - Code Enforcement Officer McDonell stated that the Planning Board noted that several agriculture projects had been started prior to site plan and SEQR approval. The Planning Board wanted directions from the Town Board, with possible steps of assigning fines or issuing stop work orders. The board directed CEO to use his judgement on the project. The board would rather not seek the issuance of fines.
 - Code Enforcement Officer McDonell spoke regarding the solar panels that were going to be installed on two different lease parcels. The panels will be on these parcels for a 25 year plan. He stated that the Planning Board would be to recommend that a reclamation bond be in place. Therefore, when the 25 year plan ended, all equipment would be removed and the property be returned to the original condition.
- B. Recreation Councilmember Putney
 - Playground equipment is being installed.
 - A year ago the Fire Department donated two fryers to the Recreation Committee. The committee found that they could not use them, and have sold them to another business.
